B.1. *Describe your organization's participation in State efforts to develop and implement measures to strengthen institutional capacities for safeguarding intangible cultural heritage (ICH) (Article 13 and Operational Directive (OD) 154), e.g. in the drafting of ICH-related policies or legislation, in the establishment of national ICH committees or in other government-led processes.*

The CICS participated in several projects planned by the Korean government to take legal and institutional measures related to the implementation of the Convention. The most significant development in the safeguarding of ICH in Korea, the Korean government enacted a new law

called ‘Law regarding Intangible Cultural Properties Preservation and Application’ in 2016. For the implementation of the new law, Cultural Heritage Administration (CHA) requested us to hold assessment seminars 4 times in 2017. The CICS invited 4-5 experts in each session and asked them to review the new law and the current situation of ICH elements and bearers. The series of discussions dealt with the cultural policies effectively safeguarding ICH in accordance with the changing circumstances of the time, and the direction of support for the bearers of ICH in all different categories. After the seminar, we analyzed the discussions and made a report. The report was submitted to the CHA for reference by the policy makers. Secondly, the CICS conducted monitoring for the National Intangible Cultural Properties (NICP) designated by CHA since 2015. In the monitoring sessions, we examined NICP’s current conditions especially on the matter involving ICH bearers, groups and communities that may have problems and difficulties in transmitting, training and other activities. Thirdly, the CICS have been participating in various government-supported projects in the fields of education, performance, and research to promote the vitalization of elements inscribed to the national list and the UNESCO’s lists. The CICS has been making reports, writing research papers and books for future improvement plans.

The CICS is operating a progressive inventory system for the management and safeguarding of ICH. It began with a close collaboration with CHA since 2010-2012. We formed a research team in order to carry out the pilot study of the digitalized form of inventory. Since 2010 we have been accumulating 800,000 ICH data, archives of ICH elements, and life history of ICH bearers. The documentation work of CICS have supported the central and local governments when they had to make inventories of ICH. Some documentation projects led by governmental bodies for the

safeguarding of ICH examples are provided as follows: ICH inventory project of Jeonju city government(2017); *Seungjeonmu* project (traditional dance transmitted in the area of Tongyeong) (2017); ICH inventory project of Jeollabukdo province (2017); Inventory of village ritual of Gochang (2017); Documentation of traditional educational systems, *Seodang* (village school) (2018); Ccultural resource documentation of Wanju County project (2018-2019); Re-documentation of falconry groups of Jinan supported by Jinan County (2019); Documentation of Haman traditional firework supported by Haman County (2019); Cultural resource documentation of Gochang County project (2020); Investigation of marine culture and folk resources of the Byeonsan Peninsula project of the National Park (2020).The CICS's documentation projects with the governmental bodies comply with fundamental philosophy of the UNESCO Convention for the safeguarding of the ICH.

The CICS researchers have been studying remote villages and communities all over the country in search of ICH in danger of disappearing. The CICS recommended endangered ICH such as the traditional Confucius funeral and educational systems to the government that had a choice to nominate them under the urgent safeguarding list. The CICS has also consulted some bearers, groups and communities regarding traditional fermented food, temple diet, and Korean traditional paper making for the preparation of nomination to the Representative List.

The activities of CICS include inventorying ICH data of various domains and regions. We use a

community-based method of inventorying in which we visit ICH holders, groups, or communities and take an ethnographic approach. We use to build up ‘rapport’ relationships with them. The bottom-up approach provides the reliability and accuracy of our inventory work. We use the internet site, www.ichpedia.org, as the main platform for inventorying ICH elements. The digital inventory method contributes to transparency and democratization of ICH data. The recent accomplishments (2017-2020) of inventorying work of ICH are as follows:

- ① Inventory making of cultural heritage play fields in the 20th century supported by CHA
- ② A research and inventory of Gastronomy in the Jeonbuk region supported by Korea Creative Content Agency
- ③ Cataloging ICH in Jeollabuk-do supported by Jeollabukdo Provincial Government
- ④ Inventorying of ICH in Jeonju city supported by Jeonju Cultural Foundation
- ⑤ Cultural resource documentation of Wanju County project
- ⑥ Inventory of village ritual of Gochang
- ⑦ Re-documentation of falconry groups of Jinan supported by Jinan County
- ⑧ Documentation of Haman traditional firework supported by Haman County
- ⑨ Cultural resource documentation of Gochang County project
- ⑩ *Seungjeonmu* project, recording of national intangible cultural properties No. 21 (traditional dance transmitted in the area of Tongyeong) supported by Tongyeong City Government
- ⑪ Documentation of the Procession for the commemoration to King Jeongjo supported by Hwaseong City Government
- ⑫ Documentation of Seodang cultural values supported by Korea Seodang Culture Promotion Association

The CICS is leading the research, inventorying and promoting domestic and international ICH by operating the ICHPEDIA website and the ICH-NGO website facilitating a platform for networking and exchange of information. The ICHPEDIA functions as a digitalized inventory system, which is being prepared to service as a platform for domestic and foreign related organizations as well as for general users. The CICS researchers and staffs are currently participating in a cultural ODA (official development assistance) with the support of the Korean

government to provide ICHPEDIA web-based inventorying to developing countries.

The ichngo.net website is the official website of the NGO FORUM approved in November of 2018. What is special about 'Ichngo.net' is the interactive online communication space for ICH NGOs from all over the world (regardless of accreditation) by directly participating and sharing their activities, news, and projects for enhancing the safeguarding of ICH. Currently, UNESCO accredited NGOs are actively promoting to the web board of ichngo.net about their safeguarding activities. Ichngo.net intends to establish an open space where various actors, including ICH holders, groups, communities, experts, policymakers, and citizens themselves participate in the online realm for finding a better safeguarding measures, policies, and any other alternatives.

Various activities of the CICS involve raising awareness of ICH. Special efforts have been made to inform the general public and especially younger generations to understand the importance of ICH. Some best practices are listed as follows. First, the CICS held 'World Intangible Cultural Heritage Forum' in the two consecutive years of 2017-2018 with the support of Center for Intangible Heritage, an umbrella organization of CHA. The international forums were held respectively under the themes of 'Intangible Cultural Heritage and Cities' and 'Intangible Cultural Heritage and Peace' (participants from Brazil, Japan, Bangladesh, Germany, Nigeria, Mongolia, Norway, Czech Republic and Slovakia, Austria, China and Canada). The purpose of the forum was to create and promote leading discourses for the protection, transmission, and achievement of sustainable development goals of ICH. Moreover, it shared information and

communicated with ICH bearers, experts, policy administrators, researchers, ICH contributors, students (undergraduate and graduate students), and to the public. Secondly, the CICS maintains a network with UNESCO-accredited NGOs in Korea (UNAK). In particular, information on major issues regarding the UNESCO's safeguarding measures for ICH and policy directions has been shared and the related materials have been published to educate the members of UNAK, as well as the public including ICH bearers, groups and communities.

The CICS conducted a cross-cultural study on tug-of-war transmitted in the four Asian countries such as Cambodia, Philippine, Vietnam and Korea. Research was done in preparation for the multinational inscription of tug-of-war. Based on the results of cross-cultural heritage studies, the multinational inscription of representative lists was successful. Secondly, as the case of regional cooperative activities, CICS supported ICHCAP, category 2 center in Korea, to participate an expert meeting on maritime ICH in 2019. The CICS played a role of exchanging information and building networks with other Asian countries that were interested in maritime cultural heritage.

The CICS has had many experiences in conducting ICH research for the designation of national and local level intangible cultural properties. During this process, the CICS have intersected several ICH domains in the cases of making and sharing *Kimchi*, traditional festivals, village rituals, traditional knowledge, skills, and handicrafts. Making and sharing *Kimchi* among others was intensively studied and submitted to the CHA for a national report. The cultural heritage encompasses several domains. Food making is basic and yet we had to figure out the intricate social networking of *Kimchi* making and sharing. Family, relatives, friends, neighbours and villagers who are discursively involved in the making and sharing *Kimchi* network was

identified. On the other hand, in order to find out the variety of *Kimchi* recipes, various methods of *Kimchi* making between regions, classes and generations were widely studied.

E.3. *Describe the experience of your organization in evaluating and analysing documents such as proposals or applications.*

The CICS prepared documents and analysed them to be sent as proposals and ICH application listings at the local and national level. First, the CICS evaluated and analyzed the various tug-of-war styles from four countries (Cambodia, Philippines, Vietnam and Korea), while implementing the cross-cultural perspectives to the study in 2015. Second, the CICS analyzed the case of haenyeo, women divers in Jeju Island which was inscribed in the Representative List. Third, Kimchi making and sharing was studied various documents regarding regional and local proposals.

Yes. The CICS had experiences in drafting texts of proposals in English based on ethnographic studies in the villages where endangered traditional hemp weaving is practiced. The traditional liquor brewing practice was endangered in another village. Both practices-hemp weaving and liquor brewing had been routine labor handled by women. Village women were neglected by the local administration offices taking responsibility of protection of ICH according to the current Korean law regarding ICH safeguarding. The CICS encouraged and helped village women to submit proposals to local offices in charge of the protection of ICH. The proposals were written in Korean then translated in English to present the cases at the international conferences held in Japan and United States.

The CICS applies its domestic experience to the safeguarding of ICH in Myanmar. The

Department of Archaeology and Religion of Myanmar government has prepared the inventor list of ICH during the recent years with the support of UNESCO and other foreign experts. Since 2019, the CICS has been involved in making inventory of ICH and digitalizing data. The Myanmar government plan to submit nomination files for good practices of ICH to UNESCO and the CICS advised and assisted in the preparation process for ICH in Myanmar.

In December of 2020, Hanhee Hahm, director of the CICS, took part in the intersectoral online expert meeting on education-related indicators in the overall results framework (ORF) for the Convention for the Safeguarding of ICH and their relationship with SDG 4. She submitted a brief report to UNESCO regarding the Korean cases on the subject matters.

In July of 2018, Hanhee Ham, director of CICS, had a presentation with the title of “Integrating the Circles of Academia and ICH practitioners in the 2018 International Forum: Unlocking the Potential of Tertiary Education for ICH safeguarding under the auspicious of ICHCAP.

In November of 2015, the first symposium for the development of ICH post-graduate programmes were held in Bangkok under the auspicious of UNESCO Bangkok office and ICHCAP. Hanhee Hahm, director of CICS, had a presentation titled with “Challenges and Validity of ICH programmes in Jeonbuk National University.”
