B.1. *Describe your organization's contribution to strengthening institutional and human capacities for safeguarding intangible cultural heritage.*

In Sweden, The Institute for Language and Folklore (here after referred to as Isof), have been assigned by the Swedish government to develop working methods connected to the 2003 Convention. The institute has developed four « nodes » for the different areas. One of these nodes focuses on oral traditions and rituals. We are actively participating in this node and attend meetings in the so-called steering group, where all nodes have representatives of experts to provide advisory services.

Between 2019-2021, the former director of our NGO was elected to the board of the ICH-NGO

Forum, first as a treasurer and then as chairperson. Our NGO have also participated in the Working Group on Research.

We are active in the network of Safeguarding practices (safeguardingpractices.com), where we are part of the steering group and have participated in several meetings both physically and digitally. In 2022, the group of Safeguarding practices held an open seminar with guests from the Nordic and Baltic countries during the annual storytelling festival of our NGO. The seminar was streamed and reached a wide audience, both nationally and internationally.

We are active in several groups and projects that focuses on promoting intangible cultural heritage: LIVIND, Kultur Österbotten, Hilmarfestivalen, Erasmus+ and several other networks.

During the years since our accreditation, we have had regular contact with Isof, The Swedish National Commission for UNESCO and the Ministry of Cultural regarding matters concerning the 2003 Convention, which have been really helpful in our work as an accredited NGO.

By working with the nodes developed by Isof, we have been given the possibility to be in contact with several governmental bodies (even if they are not in our field of storytelling/oral traditions), such as the Nordic Museum, The National Swedish Handicraft Council, The Swedish National Heritage Board, The Swedish Performing Arts Agency and The Sami Parliament. Several meetings and seminars have been held together with these bodies, both physically and digitally, during the pandemic.

Our NGO run storytelling courses at the Linnaeus University. The purpose of the courses is to train educators in various professions how to use storytelling as a valuable tool for communication in their work as well as training them in the art of storytelling. Until now we have met 14 groups with students from all over Sweden.

In collaboration with the municipality, we have courses at the cultural school where we train children and young people in oral storytelling. They also get the possibility to perform for a wide audience in our program activities.

Through project funds, we get the opportunity to transfer stories between generations and cultures. Here we meet the elderly, immigrants, minority groups. We also meet intellectually disabled people who through oral storytelling get a new way of communicating.

Members of our NGO organize program events for the public several times per semester, these programs are both performances and courses.

These collective activities provide individuals with a broad knowledge of our ICH that they are encouraged to pass on.

Ever since the NGO was founded, we have collected both old and newer stories from people in the area. Through storytelling cafes the participants share local stories and through them we can take part in the present and the past and create context and cohesion for people. At these cafes we meet both young, elderly, immigrants and minority groups. All stories are documented and included in our archive.

We are active in the social debate and participates in meetings with the municipalities in Sagobygden and the region. We collaborate with archives and other museums, schools, libraries and healthcare. We currently have collaboration partners from the Nordic countries, the Baltic States, as well as Spain and Ireland.

We supervise university students from various institutions who look at our way of working with ICH based on various cultural heritage issues.

B.4. Describe your organization's participation in developing **policies, as well as legal and administrative measures**, for safeguarding intangible cultural heritage. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

The Region of Kronoberg and the three municipalities of Alvesta, Ljungby and Älmhult have all included the promotion of storytelling in their culture plan. Today oral storytelling is one of Ljungby municipality's focus areas. This means that oral storytelling is given a large space in the municipality's various administrations, which use storytelling in care of the elderly, in schools and the corporate world. In addition, it can be seen in the cityscape, where roads are named after locations from legends and stories, and the autumn of 2022, a new playground was inaugurated with a figure that is strongly associated with ICH.

2021, the Storytelling Network of Kronoberg wrote a report in dialogue with The Swedish National Commission for UNESCO and Isof. This report contains a structure which ensure that representatives of civil society will be able to participate in the work with the 2003 Convention at national, regional and global level.

National level – Focus's on how the work with the Convention can take place and develop between the state and civil society.

Regional level – Focus's on how civil society can be active, suggestions are given on how the Nordic countries and their NGOs can cooperate.

Global level – Possible ways for Sweden to support the global work of NGOs.

Economy - An insight into the financial challenges that civil society faces when you want to act and be involved, and at the same time a reflection on what funds Sweden allocates for ICH and convention work.

B.5. Describe your organization's participation in promoting the **role of intangible cultural heritage and its safeguarding in society**. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

We work closely with the three municipalities that form Sagobygden. In different constellations within the municipality's various activities, we work on an individual level around the possibility of spreading ICH. We discuss the question of how we together can raise the intangible cultural heritage locally and nationally. In the municipality of Ljungby, we are one of four focus areas, which means that the municipality actively participates in the work of raising and promoting our work on oral storytelling. This means that oral storytelling is given a large space in the municipality's various administrations, which use storytelling in care of the elderly, in schools and the corporate world.

During our annual storytelling festival, we invite nationally and international guests to seminars where intangible cultural heritage is discussed from several different angles. In recent years, these seminars have been streamed online, and thus, we have reached a wide audience both nationally and internationally.

In collaboration with Isof, we continuously discuss how we can be an active partner in matters related to the work with intangible cultural heritage.

Since the autumn of 2021, a scientific council has been linked to the Storytelling Network. The council examines the association and its operation and looks at possible development opportunities. The council consists of researchers in pedagogy, ethnology, archaeology, design and entrepreneurship. The researchers include our working method in several courses, and we are part of two major research projects where we meet other museums and researchers outside our field

We have a constant dialogue with our members and other stakeholders regarding the understanding and work with the 2003 Convention in lectures and seminars. In 2022, we held a one-day seminar together with our scientific council, where we talked about our activities, and they gave their view on opportunities to develop the same. Politicians, government officials as well as local and national NGOs with an interest in intangible cultural heritage participated.

The association is continuously looking for project funds to develop its operations and we would like to mention two projects that have spread nationally as good examples.

Livsviktiga berättelser (Vital stories) – a collection of contemporary stories connected to local places. The stories will be recorded and posted on our website, as part of our "Storytelling treasure", which already contains over 250 stories. Through the "Storytelling treasure" we meet an ever-growing audience within schools, museums, members, companies, and others interested in our living cultural heritage. The second project, "Sägenresan Sverige", is a digital map with legends from all over the country (<https://sagenresan.sagobygden.se/>). The map is distributed through our website, free for everyone to use, and through our broad schoolwork.

The Storytelling Network offers a wide range of educational programs in preschools, schools and cultural schools. Here, children and young people encounter the rich world that oral storytelling offers.

Local citizens as well as tourists can encounter stories in The Museum of Legends, which offers guided tours throughout the year, in Swedish, English, German and Danish. The landscape is brought to life through our legendary cabinets and storytelling performances at several of these locations during the summer months. Attendees are tourists and locals in all ages with different nationalities.

Throughout the year, we draw attention to storytelling and its areas of use, through lectures, performances, and courses. We meet local stakeholders, and travel to several parts of Sweden and abroad. We have held several large lectures and participated in conferences in countries such as Latvia, Lithuania, Norway, Finland, Denmark.

In Sweden, the work with the 2003 Convention is divided into areas, so-called "nodes", where Isof is the coordinator. Here we actively participate in discussions with groups in various areas around ICH. Our position in this network is advisory.

We are active members of several networks in the Nordics and the Baltic countries connected to ICH, where we carry out joint projects to promote and spread the 2003 Convention in different ways.
